From Austin County:

Start out following FM-1094W to New Ulm. Turn left onto FM-109S/Ernst Pkwy and continue straight onto FM-1291N. Turn left onto FM-2503 and continue onto Ross Street. Turn right onto TX-71W. Take the exit toward US-77/Giddings/Schulenburg and merge onto TX-71 Frontage Road. Turn right onto North Jefferson Street (US-77). Turn left onto Veterans Memorial Drive and continue straight onto West Fair Grounds Road.

From Colorado County:

Start out on TX-71 towards Austin/La Grange. Turn left onto the I-10W/TX-71W ramp to San Antonio. Keep left and merge onto I-10W. Take exit 695 for TX-71W toward La Grange/Austin. Continue TX-71W. Take the exit toward US-77/Giddings/Schulenburg and merge onto TX-71 Frontage Road. Turn right onto North Jefferson Street (US-77). Turn left onto Veterans Memorial Drive and continue straight onto West Fair Grounds Road.

From Washington County:

Start out taking US 290 West to HWY 237 towards Round Top. HWY 237 becomes HWY 159. Turn right onto TX-71 Frontage Road. Turn right onto North Jefferson Street (US-77). Turn left onto Veterans Memorial Drive and continue straight onto West Fair Grounds Road.
